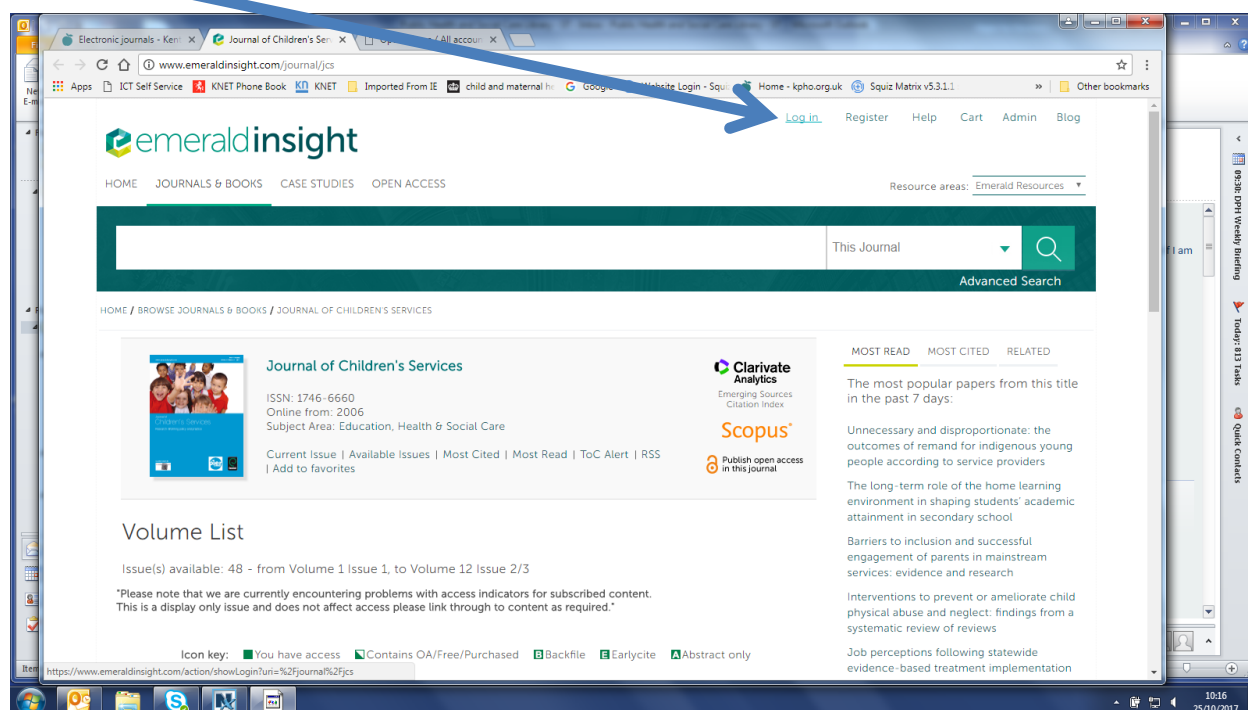
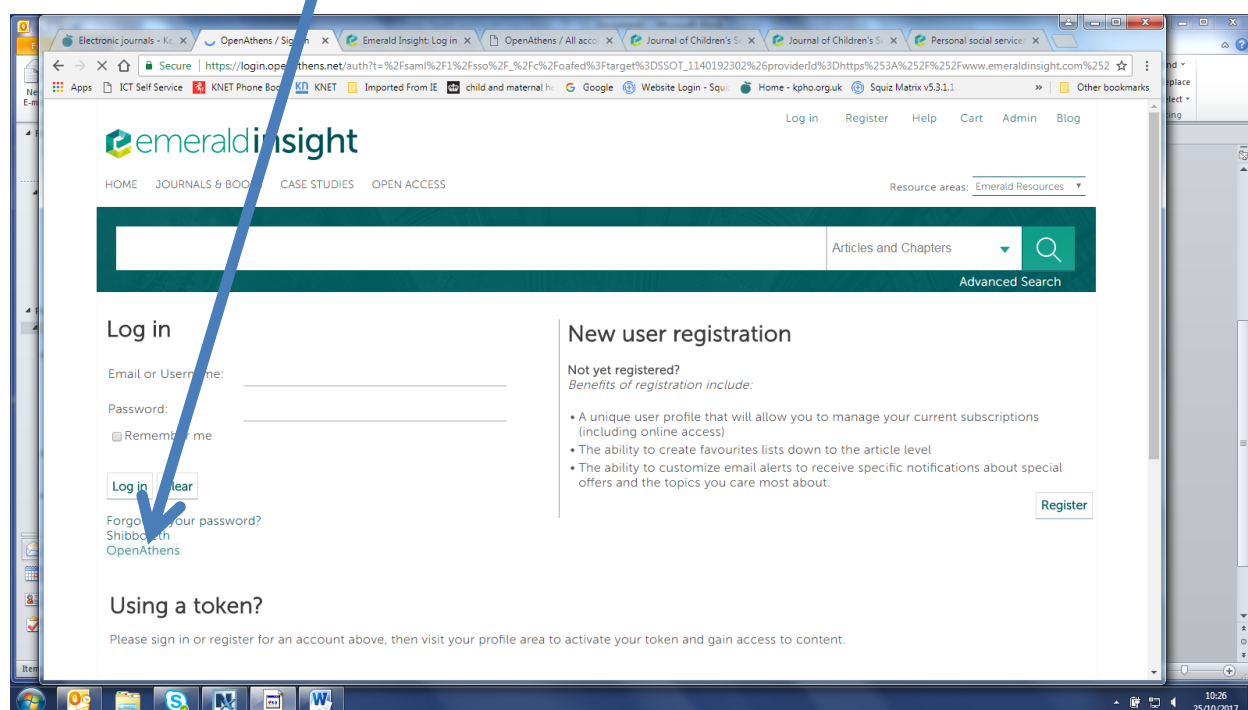


Click on "log in"
